


# OFFICIAL HUNTING MAP OF DELAWARE STATE PARK

1. Sunday hunting is prohibited except waterfowl.
2. Archery hunting is permitted in season for deer and turkey. Coyote trapping may only occur during deer and turkey archery seasons in designated areas.
3. Hunting with a firearm or muzzleloader is prohibited except while waterfowl hunting on the lake and designated areas.
4. Deer drives are prohibited in any area of the park.
5. Day-use deer stands and duck blinds may not be left unattended. They must be removed at the end of the day. Use of screws and nails into trees is prohibited.
6. Park only in designated areas. No parking in front of gates, in driveways, on side of roadway or in service area. Beach parking lot may be used with permission.
7. Hunters are to follow all hunting hours and restrictions listed by the Division of Wildlife in addition to park rules.
8. No person shall at any time hunt, trap, kill, pursue; or shoot at any wildlife and/or wild animals within 200 feet of Mink Run, Briar Patch, Lakeview, or Fisherman's trails; picnic areas; state trail; service building; shelter house; beach; water or sewage treatment facility; latrine; parking lot; or any road or driveway within the area administered by the division.
9. Hunting is permitted on the beach for early goose season in September until 10am unless posted by the park.
10. Target shooting by means of firearm, muzzleloader, air rifle, or archery implement is prohibited in the park, with the exception of hunters unloading crossbows safely into the ground or portable target.

Pursuant to Ohio Administrative Code, no person shall at any time take, hunt, trap, kill, pursue, or shoot at any wildlife and/or wild animals by any means within four hundred feet of any nature trail, picnic area, construction area, state trail, service area, camping area, residence, barn, service building, shelter house, beach, water or sewage treatment facility, backpack trail, latrine, parking lot, cabin, lodge, or other structure or to shoot on, from, or across any road, or driveway within any area administered by the division.
